My name is Ina Rayette Egenriether. I am a white female and I am 42 years old, having been born 11-10-58. My home address is 5946 Woodmancote Humble, Texas 77346 and my home telephone number is 281-852-8104. I can also be reached at 281-446-1625. My Missouri drivers license number is [REDACTED]. My Social Security number is [REDACTED]. I have attained 12 years of formal education.

I MET BOBBY OVER A YEAR AGO IN A MEAT MARKET OFF OF ALMEDA GENOA. A FRIEND OF MINE, MARVIN PHILLIP INTRODUCED US. WE WERE FRIENDS FOR A LONG TIME AND EVENTUALLY BEGAN DATING AND BECAME BOYFRIEND AND GIRLFRIEND. I MOVED IN WITH BOBBY ABOUT FIVE WEEKS AGO ON WOODMANCOTE DRIVE.

AS FAR AS I KNOW BOBBY HAD NEVER BEEN IN TROUBLE WITH THE LAW AND I DO NOT REMEMBER ANYONE MAD AT HIM OR HAVING A GRUDGE AGAINST HIM. I CAN NOT THINK OF WHY ANYONE WOULD WANT TO HURT HIM. BOBBY DOESN'T HAVE A STEADY JOB BUT HE ALWAYS HAS MONEY.

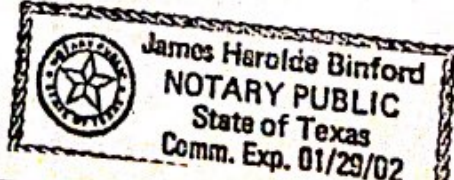
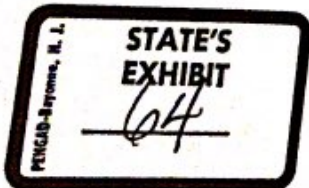

BOBBY HAS A BROTHER BY THE NAME STEVE BROWN WHO LIVES IN NORTH CAROLINA AND IS CURRENTLY IN JAIL. I DON'T REMEMBER THE CITY BUT I KNOW BOBBY'S MOTHER LIVES IN NORTH CAROLINA ALSO.

TONIGHT WE DIDN'T GO OUT AND WE JUST SAT AROUND THE HOUSE AND HAD SOME DRINKS. I DRANK SOME WHISKEY AND BOBBY HAD SOME WHISKEY AND A COUPLE OF BEERS. WE PLAYED WITH HIS NEW PUPPIES DURING THE NIGHT. I DON'T REMEMBER WHAT TIME IT WAS BUT BOBBY ASKED ME IF I WANTED TO GO GET SOME COFFEE AND BREAKFAST. I SAID YES AND WE GOT INTO HIS TRUCK. HE DIDN'T SAY WHERE WE WERE GOING TO EAT AND WE LEFT THE HOUSE.

I THINK WE TOOK 59 SOUTH FROM HUMBLE AND WE WERE ON THE SERVICE ROAD WHEN A SHINY SILVER OR GOLD CAR THAT I THINK HAD FOUR DOORS DROVE UP ON THE DRIVERS SIDE OF THE TRUCK. THERE WERE TWO BLACK MEN IN THE FRONT SEAT. I DON'T REMEMBER WHAT THEY LOOKED LIKE JUST THAT THEY WERE BLACK. THE PASSENGER HOLLERED AT BOBBY BUT I DIDN'T HEAR WHAT HE SAID. BOBBY'S WINDOW WAS HALF WAY DOWN. THE MAN HOLLERED A SECOND TIME AT BOBBY AND BOBBY YELLED "FUCK YOU OR FUCK OFF". I'M NOT CERTAIN WHAT BOBBY SAID BUT I REMEMBER HE USED THE WORD FUCK. THE BLACK MAN SAID HE WAS GOING TO SHOOT BOBBY AND I TOLD BOBBY TO BE CAREFUL. BOBBY TOLD ME THE GUY WASN'T GOING TO SHOOT.

THE CAR DROVE IN FRONT OF US AND BOBBY SAID "HE REALLY HAS A GUN, HE IS GOING TO SHOOT". I SAW THE PASSENGER LEAN OUT OF THE PASSENGER WINDOW WITH A GUN AND POINT IT TOWARDS THE FRONT OF THE TRUCK AT US. I GOT DOWN ON THE FLOORBOARD AND I HEARD A GUNSHOT. I DON'T REMEMBER HOW MANY TIMES THE MAN SHOT BUT I REMEMBER HEARING AT LEAST ONE GUNSHOT. I FELT THE TRUCK RATTLE AND THEN IT STOPPED. I DIDN'T KNOW WHAT HAPPENED BUT WHEN I LOOKED UP SAW BOBBY LEANING DOWN AND HE WOULD NOT ANSWER ME. I SAW BLOOD SQUIRTING OUT OF HIS HEAD AND I TRIED TO GET HIM TO WAKE UP BUT HE WOULDN'T.

I GOT OUT OF THE TRUCK AND RAN BECAUSE I THOUGHT THE MAN WAS GOING TO GET ME. I ENDED UP AT THE STREET LIGHT AND TRIED TO GET SOMEONE TO HELP ME BUT NO ONE WOULD STOP. I WENT BACK TO THE TRUCK AND CHECKED ON BOBBY AND HE GRABBED MY HAND AND SQUEEZED MY ARM AFTER I TOLD HIM I LOVED HIM.
